

School Context

Surfside Primary School is a medium to large sized school. The school has been in operation since 1993. It is located in a residential area 2 km north/east of the central business district of the seaside resort of Ocean Grove, 28 kilometres from the provincial city of Geelong, on Victoria's Bellarine Peninsula. Our Vision is 'to inspire students to be creative, innovative and emotionally equipped to thrive' while our Mission is to 'cultivate a caring and inclusive environment in which students flourish' and is supported by our school Values of 'Respect, Honesty, Teamwork and Achievement'

Policy Framework

The policy states that all eligible children and young people have the right to be admitted to their designated neighbourhood government school.

2026.2027 Surfside Primary School zone

The Surfside Primary School zone has been approved by the Minister for Education and ensures consistency with DET policy and the ETRA legislation regarding closest school.

A student's designated neighbourhood school is generally the school that is nearest the student's permanent address as determined by the school zone. The website <https://www.findmyschool.vic.gov.au> provides guidance on which school zone a student's permanent residence is located within.

Priority Order of Placement

The potential future demand for enrolment places from within the local community indicates that Surfside Primary School must manage enrolments carefully and in accordance with the Priority Placement Order in the Enrolment Policy. A student's permanent place of address determines eligibility for enrolment at Surfside Primary School.

Where there are insufficient places at a school for all students who seek entry, students are enrolled according to the Placement Policy's priority order of placement, which has five criteria.

Our school has an enrolment restriction under section 2.2.16 of the Education and Training Reform Act 2006 (Vic). Approved entry criteria for our school are:

1. **Students who live within the school zone**
2. **Students with a sibling at the same permanent address who are attending the school at the same time.**
3. **Students seeking enrolment on compassionate grounds, in exceptional circumstances.**

In exceptional circumstances, a student may be enrolled in a school based on compassionate grounds. **This is an overarching consideration and does not form part of the priority order of placement.** Schools are permitted to assess and make a determination for exceptional circumstances on a case-by-case basis.

Schools must ensure that all applicants eligible under a criterion have been offered a place before moving to consideration of the next. All students for whom the school is the designated neighbourhood school are guaranteed enrolment.
